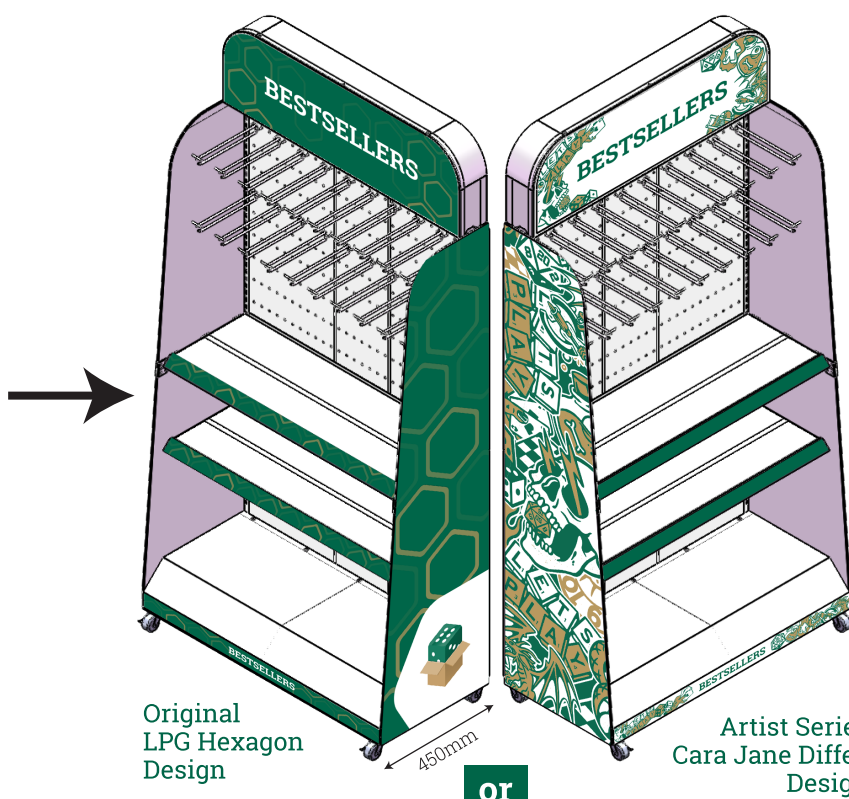

LPG Stand Program Agreement

1. Introduction

Let's Play Games believes that an effective store display is an important tool for any retail store. This agreement will set out a series of incentives that reward stores that maintain the LPG stand program.

2. Scope

Let's Play Games agrees to provide one or more LPG ES0001 stands and appropriate signage with the following provisions:

The stand will be provided at no charge alongside appropriate stock to fill the stand, to be invoiced to the customer

The delivery of the stand will be organised by LPG

The stand will be committed to an agreed RANGE,
LPG will provide a RANGE planogram

LPG reserves the right to change the pricing and product mix in the planogram quarterly.
Changes in pricing and product mix will have a minimum of one-month communication.

The LPG ES0001 stand remains the property of LPG

3. Benefits

Let's Play Games agrees to provide these benefits to stores that maintain the terms of the LPG Stand Agreement

The stand will be provided at no charge

LPG will cover the delivery of the stand and signage

LPG agrees to provide the LPG Stand pricing structure for the committed RANGE. This pricing structure is an additional per-product discount.

LPG can provide stand signage at no additional cost.

4. Terms

A store qualifies for the benefits if:

The store agrees to keep the stand supplied at the RANGE's planogram level.

The store agrees to an LPG stand check-up at an agreed-upon time interval. This can include photographic evidence and sell-through reporting.

The store agrees to maintain the stand at an appropriate retail readiness level, including appropriate signage.

The store agrees to accept delivery and pay for all shipments from LPG, which restores the inventory levels of the RANGE to the planogram stock level.

The store is an Australian or New Zealand retailer

The store is a Brick and Mortar retailer. Brick-and-mortar refers to a traditional business with a physical store or store where customers browse and make purchases in person.

Appendix - Confidentiality and Termination

1. Confidentiality

Both parties agree to treat any confidential information shared during the course of this Agreement as strictly confidential. They shall not disclose or use such information for any purpose other than fulfilling the obligations of this Agreement. This includes:

- LPG Stand RANGE price structure
- The contents of this agreement

2. Termination

This Agreement shall commence on the signed date and shall continue until terminated. Either party may terminate its commitment to the Stand Program with seven days' written notice at any time.

LPG may terminate a store's LPG Stand Agreement and the entitlement of that store to any Benefits by giving written notice to the Trade Account if a Stockist Outlet fails to satisfy the terms.

LPG may terminate a store's LPG Stand Agreement and the entitlement of any Rewards, without liability, immediately upon giving written notice to the Trade Account if the store abuses any of the Benefits. Such abuses include, but shall not be limited to

- Re-allocation of Benefits to other stores
- Use of Benefits in other sales channels other than a Bricks and Mortar store

Upon termination of the LPG Stand Agreement, the store agrees to allow LPG to recover the stand.
